Minutes of regular meeting with NFBOA by-law vote 9/11/24

Dave Burke called the meeting to order at 12pm

**MEETING REMARKS:** After the Pledge of Allegiance and a moment of silence for 9/11, the treasurer's report and secretary's report for the July meeting was accepted by the membership. Scholarship applications have been reviewed.

**SECRETARY'S REPORT:** The secretary's report for the July meeting was posted to the website prior to acceptance by the membership.

**TRESURER'S REPORT:** The treasurer's report for the July meeting was posted to the website prior to acceptance by the membership.

**DELEGATE'S REPORT:** Rod Cameron reports that we have not gotten any information as to when the code updates will take effect. The building code updates will be effective a different time than the energy code updates. The next delegates meeting is September 20th.

**EDUCATION:** Doug Gesel reports all but 7 hours of training are scheduled. We are on schedule for the conference. The State has not gotten back to us on possibility that the code updates will be added to the training. Registration will begin in the next few weeks. An email will be sent out at that time.
